Minute of the NZOS Management Committee Meeting PGI Chandigarh on March 7, 2010

1. Approval of minutes of the Management Committee of the NZOS held at Epicenter, Gurgaon on October 2, 2009.
Minutes of the MCM held on Oct 2, 2009 at Gurgaon were approved except one agenda Item (item no. 10). Representatives from UKSOS Dr. Mathur and Dr. Arora felt that there lack of clarity that it applies only to UKSOS or the existing member societies should also be paying the registration amount.
2. To consider and approve the academic program of the 24th Annual Conference. Chairman Scientific Committee to provide details.
Scientific program for the next NZOS meeting at Uttrakhand was discussed. It was decided to hold the NZOS and UKSOS meeting jointly. Day one will have UKSOS program and 2nd and 3rd days will have NZOS program. It was decided that main theme for the conference this year will be cataract surgery.
3. Report of the treasurer.
The treasures of the NZOS Dr. Dharamvir Challia has submitted his resignation due to personal reasons and did not attend the meeting. Therefore, Treasures report could not be submitted.
4. Submission of Accounts of the 22nd Annual Conference held at Ludhiana:
Audited statement of the accounts pertaining to the 23rd NZOS conference held at Ludhiana in 2008 was submitted by Dr. Rajinder Singh, organizing secretary of the conference. The statement was accepted by the Management committee.

5. Submission of Accounts of the 23rd Annual Conference held at Gurgaon:

Dr. Ajay Sharma, Organizing secretary of the 23rd NZOS conference did not attend the meeting nor he submitted the accounts. It was decided to remind him to do so in the next Management Committee Meeting.

6. Venue of the 24th Annual Conference (to be held in Uttarkhand).

It was decided that next conference of the NZOZS will be held Jointly with UKSOS conference at Missouri. Dr. BK Oli was nominated as Organizing secretary for the 24th conference of the NZOS by UKSOS.

7. Resignation by the treasurer NZOS, Dr. Dharamvir Chalia.

Resignation of the Treasurer NZOS was accepted. Management committee nominated Dr. Gagandeep Singh Brar, joint treasure to the post of treasurer, who agreed to look after the accounts of NZOS.
